What data do we collect?

memecat collects the following data:

- Personal identification information (email address).

How do we collect your data?

You directly provide memecat with all the data we collect. We collect data and process data when you:

- Register online or complete our registration form.
- Voluntarily provide feedback via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Our Company collects your data so that we can:

- Process registration.

- Email you with special offers.
- Email you with information about airdrops, token launches, pre-sale information and DEX or CEX listings.

How do we store your data?

memecat securely stores your data using MailChimp.

memecat will keep your email address for 12 months. Once this time period has expired, we will delete your data.

What are your data protection rights?

memecat would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request memecat for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that memecat correct any information you believe is inaccurate. You also have the right to request memecat to complete the information you believe is incomplete.

The right to erasure – You have the right to request that memecat erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that memecat restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to memecat's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that memecat transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us at our email.

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we

may collect information from you automatically through cookies or similar technology
